1 A BILL making a supplementary appropriation by adding a new item and increasing the  
2 expenditure of public moneys out of the Treasury from the balance of moneys remaining  
3 as an unappropriated balance in the State Fund, General Revenue, to the Department of  
4 Revenue, State Budget Office, fund 0595, fiscal year 2019, organization 0703, by  
5 supplementing and amending the appropriations for the fiscal year ending June 30, 2019.

6 WHEREAS, The Governor submitted to the Legislature the Executive Budget document,  
7 dated January 9, 2019, which included a Statement of the State Fund, General Revenue, setting  
8 forth therein the cash balance as of July 1, 2018, and further included a revised estimate of  
9 revenues for the fiscal year 2019, less net appropriation balances forwarded and regular  
10 appropriations for the fiscal year 2019; and

11 WHEREAS, The Governor submitted to the Legislature an Executive Message dated  
12 March 5, 2019, which included a revised estimate of revenues for the State Fund, General  
13 Revenue and a statement of the State Fund, General Revenue for the fiscal year 2019; and

14 WHEREAS, The Governor submitted to the Legislature an Executive Message dated May  
15 20, 2019, which included a revised estimate of revenues for the State Fund, General Revenue  
16 and a statement of the State Fund, General Revenue for the fiscal year 2019; and

17 WHEREAS, The Governor submitted to the Legislature an Executive Message dated June  
18 17, 2019, which included a revised estimate of revenues for the State Fund, General Revenue  
19 and a statement of the State Fund, General Revenue for the fiscal year 2019; and

20 WHEREAS, It appears from the Statement of the State Fund, General Revenue, and  
21 Executive messages, there remains an unappropriated balance in the State Treasury which is  
22 available for appropriation during the fiscal year ending June 30, 2019; therefore

*Be it enacted by the Legislature of West Virginia:*

23 That the total appropriation for the fiscal year ending June 30, 2019, to fund 0595, fiscal  
24 year 2019, organization 0703, be supplemented and amended by adding a new item of  
25 appropriation as follows:
