The Committee on Agricultural and Rural Development met on Tuesday, August 22, 2017 at 12:00 p.m. in the Senate Finance Committee Room.

Representatives from around the state discussed the economic and cultural impact of the State Fair and other Fairs and Festivals with an emphasis on small business development, local food products and agriculture.

Kelly Collins, CEO of WV State Fair, addressed the Committee regarding the cultural and economic impact of the State Fair of WV. She presented a handout with facts and figures about

the State Fair. Ms. Collins stated that in 2016 the fair gave back more than \$250,000 to the state in sales tax within a ten-day span. It also has a huge cultural impact. Over 450 youth exhibitors come to the State Fair for their 4-H and FFA livestock, junior horse and pony shows. The fair spends about \$43,000 in awards presented to youth winners.

Jerry Cook, Chairman of WV State Fair Board of Directors, introduced himself.

Tom Campbell, WV State Fair Board of Directors and President of State Board of Education, addressed the Committee. He discussed the effect of early school start dates on the fair, and the positive economic impact that a later school date would have for the fair and the state. He indicated that Maryland had a positive economic impact to their state from the delay in school openings because more students and teachers could work and attend the fair. In lowa, the Governor delayed school start dates to after its state fair because it promoted agriculture and added revenue to the state. Tourism is also affected by schools starting early. The State Board of Education has discussed this issue informally.

Crescent Gallagher, Communications Director, WV Dept. of Agriculture, addressed the Committee and discussed the Department of Agriculture's involvement and impact on the State Fair. The DAG inspects approx. 2,368 animals at the fair, and holds stakeholder meetings for WV Farmers' Markets and the Veterans and Warriors to Agriculture program.

Cassey Bowden, Director, WV Dept. of Agriculture, Business Development Division, indicated that the WV Country Store was reopened and run by the department. It had 35 "West Virginia grown" vendors with multiple products, and was successful.

Gavin Ward, Vice-President, WV Association of Fairs and Festivals, gave a presentation on the general overview of the fairs and festivals in the state, their economic impact and importance to small communities.

Cassey Bowden, Director, WV Dept. of Agriculture, Business Development Division, spoke about the Jamboree and the revenue it brought to the State.

## September 2017
